NYKAA- A Beautiful Business

If you are an investor or a beauty enthusiast, you are bound to have heard about Nykaa. Being the only profitable company among the lot of new age tech companies, Nykaa deserves the buzz it has been garnering for the speculation around its IPO.

But what is the special ingredient which makes it stand out and be the one in the spotlight, as it's name means in the language Sanskrit.

So before understanding the intricacies of the business Nykaa involves in, let's get some background about the conception of how it came to be.

Falguni Nayar is the brain behind the beauty business of Nykaa and it was once when she chanced to step in a Sephora store, dazzled by the multiple brands, the retailer dealt in and the unbiased approach of the sales team in helping her select the best products for her. She left the store, spending a hundred dollars and with an idea that turned out to be worth a billion dollars.

So it was in 2012, after an exhaustive and immersive profile of Investment Banker at Kotak Securities, Nayar left the position of Managing Director in the IB division.

However, Nayar knew the likes against whom she would be competing. So, they chose to be a specialist in the niche of fashion products unlike the generalist e-commerce platforms such as Amazon or Flipkart.

Nykaa went a step ahead in 2014 adopting an omni channel approach launching its retail store. Also realising the need for a product under Nykaa's own private labels. They came out with a range of products under their own hood.

Also realising the need for a platform that catered to men grooming products, Nykaa also came out with NykaaMan in 2019 to provide for the needs of the often left out men when the grooming and fashion industry is under radar.

However, the key to Nykaa's success is attributed to quite the way they have reached to their audience. Their approach of tying up with beauty influencers and building a cult around their brand is what may be called a brilliant marketing strategy. Their primary target audience, teens and young adults seeing their favorite creators using these products due to the connection they felt with them unlike top grade actors and models whom they looked upon as someone different from their being.

Exclusive tie ups with premium brands along with a wide range of products from them unlike other sellers only having some products from these brands or the commoners. Brands such as MamaEarth which either sells through Nykaa or Sephora also gives them mileage as the latter only sells physically.

Purple, another brand often labeled as a competitor to Nykaa also couldn't be said to be so as they only deal in limited brands and only through the digital medium.

All men who have achieved great things have been great dreamers.

Therfore, as such their are few competitive threats to Nykaa in the beauty niche particularly.

However, another factor that makes Nykaa stands out is unlike selling the proposition of "discounted products". Their focus area is their intimately curated range of goods they offer to the customers with an inventory management system at place that exceeds other players in the retail segment.

The future prospects of Nykaa also seems good with it expanding footprints in the fashion sector, however, this particular segment has some good players with the likes of Ajio & Myntra. The future cash flows as per the company will be used to set up additional warehouse over the period of next five years along with 100 retail stores to take on that front as well.

The solid background of Nayar as an IB also helps her business decisions get more fine tuned and achieve better success. This also helps the firm develop a cloud around its business due to the transparency with which she brings forth the company's information.

Fun Fact about Nykaa: Maybelline – The Colossal Kajal is the top-selling product on Nykaa with around 18000 units sold till now. It seems that this Kajal has left some deep shades in Nykaa's books.


