### ELIGIBILITY OF EXPENSE ON EDUCATION OF PARTNERS/ DIRECTORS/ PROPRIETORS/MEMBERS INCOME TAX ACT, 1961 & GOODS & SERVICES TAX ACT, 2017

# OVERVIEW OF SECTION 30 TO 36 OF THE INCOME TAX ACT, 1961

Sections 30 to 36 of the Income Tax Act pertain to deductions allowed for various business expenses in India. Section 30 deals with deductions for rent, repairs, and insurance of business properties. Section 31 allows deductions for repairs and insurance of machinery, plant, and furniture. Section 32 covers depreciation on tangible assets, while Section 32AC deals with investment allowance. Sections 33 and 33AB cover development allowances. Section 35 allows deductions for expenses on scientific research, while Sections 35AD and 35CCC cover specified businesses and renewable energy projects, respectively. Lastly, Section 36 provides for deductions on interest payments and other specified expenditures incurred for business purposes.

#### **UNDERSTANDING SECTION 37**

The Section 37 of Income Tax Act, 1961 is a general one allowing an assessee to claim deduction against expenditure made for the purposes of computing the income chargeable under the head "Profit and Gains of Business or Profession".

#### Eligibility for claiming deduction u/s 37:

- Not being of the nature described in Section 30 to 36
- Not being in the nature of capital expenditure or personal expense of assessee
- Laid out or expended wholly and exclusively for the purposes of business or profession
- Should not be for purpose which is an offence or prohibited by law
- Should not include expenditure towards CSR (Corporate Social Responsibility) u/s 135 of The Companies Act, 2013
- Not being advertisement in any souvenir, brochure, tract, pamphlet or the like published by a political party

#### **ANALYSIS OF SECTION 35AB**

Section 35AB of the Income Tax Act, 1961 allows deduction on expenditure incurred for acquiring any know-how for use for the purposes of business.

As provided vide explanation - 'Know-how' means any industrial information or technique likely to assist in the manufacture or processing of goods or in the working of a mine, oil well or other sources of mineral deposits (including the searching for, discovery or testing of deposits or the winning of access thereto).

\*\*Section 35AB can be relied upon while supporting the claim to treat education expense of the assessee as a deductible expense where the assessee has incurred expenditure on any industry- specific training or courses that offer information to assist in the manufacturing/ processing of goods or in mines, wells and mineral deposits.



#### POINTS TO CONCLUDE

- If substantial pecuniary advantage arises as a result of expenditure on education of the person;
- If pre-education & post-education business relationship are established and well documented;
- If the educational course has a direct nexus with the nature of business or profession;
- Should not be capital in nature or towards the personal expense of the assessee;
- Should be able to submit that it was a part of well- strategised management decision to incur the educational expense for benefit of the business;
- And that the business remains operational during such period;

Then the assessee can firmly hold and argue that such expenditure incurred on education of a member of the business entity was wholly and exclusively for the purposes of business and the same shall be allowable u/s 37 of the Income Tax Act, 1961 as a deductible expense.

# INPUT TAX CREDIT OF EDUCATION EXPENSE UNDER GST LAW

- Business Purpose: In order to claim input tax credit, the expenses must be incurred for the purpose of the business. While education expenses for employees may sometimes be considered for input tax credit if they are directly related to the business activities, expenses for partners' education may not qualify under this criterion.
- **Personal Nature:** Education expenses, especially those for partners, are often considered personal in nature rather than directly related to business activities. As such, they may not meet the requirement of being incurred for the purpose of the business.
- Compliance and Documentation: Even if an expense could potentially be eligible for input tax credit, proper documentation and compliance with GST regulations are essential. Failure to meet these requirements may result in denial of input tax credit or other penalties.

Though if it is well established from the facts of the case that the education expenses were incurred solely for the benefit of business and in the course or furtherance of business, the ITC on such amount shall be available to the assessee. Further, with proper documentation and other legal compliances it is fairly arguable to claim the corresponding ITC.
