BUDGET 2024

The highlights that can be drawn from the Budget 2024 are as follows –

- **DEBT RECOVERY TRIBUNALS** Additional tribunals to be established to enhance debt recovery process leading to faster compliance of legal laws and regulations which is time saving for the people of our country.
- **DIGITAL INFRASTRUCTURE** Infrastructure of our country India will be improved leading to innovation, productivity and growth of business opportunities which would be a step towards achieving the mission to make India a Five trillion sector economy by 2027.
- **CRITICAL MINERAL MISSIONS** New mission has been implemented to acquire scarce minerals overseas using superior capital assets as being introduced recently by India and Japan.
- **OFFSHORE MINING** Offshore mining will be undertaken so as to reduce the import of crude oil and petroleum as has been increased recently from Russia and Middle eastern countries.
- **INFRASTRUCTURE DEVELOPMENT** 11 Lakh crore shall be allocated for infrastructure development which represents 3.4% of GDP.

- **BUDGET PRIORITIES** Focus shall be on productivity, job, social justice, urban development, energy security, infrastructure and reforms.
- **YOUTH EMPLOYMENT** Incentives for 30 lakh youths entering the job market including one month Provident fund contribution and working women hostels.
- **CUSTOM DUTY CHANGES** Reduction in customs duty for mobile phones and chargers to 15%, gold and silver to 6% and platinum to 6.4%, duties exempted on 25 key minerals aiding tech and energy sectors to focus on making India a 0% emission country by 2060, duties on telecom sector increased to 15% to support domestic production, Fish feed and brood stocks at 5% duty, ammonium nitrate duties up, exemption for solar capital goods to drive renewable energy growth and new tariffs and export hubs to streamline imports and aid MSMEs.
- **GST HIGHLIGHTS** Existing GST rates maintained for consistent business operations, new measures ease GST compliance as there is around monthly collections of 1.66 lakh crores showing tax base growth, reforms being undertaken to streamline GST ITC Distributions business needs to adapt, new penalties has been implemented for non compliance in high risk sectors like tobacco and pan masala, Section 74A introduce clarity and efficiency in tax assessments and there has been faster custom release and improved logistics benefitting international trade.
- INCOME TAX HIGHLIGHTS Standard deduction increased from 50000 to 75000, tax on Short term capital gain increased from 15% to 20%, long term capital gain increased from 10% to 12.5%, exemption on capital gain increased from 100000 to 125000, indexation allowed while calculating capital gain has been discarded leading to huge payment of income tax while purchasing house property, security transaction tax of futures has been increased from 0.0125% to 0.02% and in case of options it has increased from 0.0625% to 0.01%.

BUDGET 2024: INCOME TAX UPDATES

Budget is one of the most common factor which decides how our country is going to perform this time on different sectors and also provision for citizens.

With this note here's the Key Highlights of Budget 2024

Income Tax Slab Changes

- No tax up to ₹3 lakh.
- 5% tax from ₹3 lakh to ₹7 lakh.
- 10% tax from ₹7 lakh to ₹10 lakh.
- 15% tax from ₹10 lakh to ₹12 lakh.
- 20% tax from ₹12 lakh to ₹15 lakh.
- 30% tax above ₹15 lakh.

Standard Deduction Increase

- Standard deduction for salaried employees increased from ₹50,000 to ₹75,000 under the New Tax regime.

Capital Gains Tax

- Short-term gains on certain financial assets taxed at 20%.
- Long-term gains on all assets taxed at 12.5%.
- Exemption limit increased to ₹1.25 lakh per year for capital gains on certain financial assets.

Custom Duty Changes

- Custom duty on mobile phones, mobile PCBA, and mobile chargers reduced to 15%.
- Customs duties on gold and silver reduced to 6%, and platinum to 6.4%.

STT on Futures and Options

- Security Transaction Tax (STT) on futures increased to 0.02% and on options to 0.1%.

Education Loan Support

 Loans up to ₹10 lakh for higher education with e-vouchers for 1 lakh students annually, offering a 3% interest subvention.

PM Awas Yojana

- Increased allocation to the PM Awas Yojana for affordable housing, focusing on providing housing for all by 2024.

MSME Credit Guarantee

- New Credit Guarantee Scheme for MSMEs in the manufacturing sector.

Enhanced Mudra Loans

- Mudra loan limit increased to ₹20 lakh from ₹10 lakh for successful previous borrowers.

Internships in Top Companies

- ₹5,000 monthly allowance and ₹6,000 one-time assistance for internships, with companies covering training and 10% of internship costs from CSR funds.
